Sending or visiting

You can send your guilder banknotes to us by post or schedule an appointment to visit our exchange counter.



Sending

Send us this application form by post and be sure to include a copy of your ID document and of a bank statement. You can choose to include your guilder banknotes or await our decision. Once we have informed you that we will consider your application, you can send us the banknotes.

Please note: You may send a maximum of €4,000 by post. If the value of your banknotes is higher, we ask that you contact us to schedule an appointment at our exchange counter in Amsterdam.



Visiting

To schedule an appointment, first send us this application form by post and be sure to include a copy of your ID document and of a bank statement. We will send you confirmation after we have received your application, informing you how to schedule an appointment to visit our exchange counter in Amsterdam.

If the amount does not exceed €1,000, you can contact us immediately to schedule an appointment. Tel.: +31 20 524 27 27 on Monday to Friday between 9:00 – 12:00.

When you visit our exchange counter in Amsterdam, be sure to bring your guilder banknotes, this application form, your ID document and a bank statement.
