

Handling rejection reasons for marketable assets



In this document, we will explain how to retrieve and understand the reason in case a marketable asset instruction in ECMS gets rejected in U2A.

Pre-requirements


The minimum roles that need to be assigned to the user in the reference data module:

“ECMS ENTITY - U2A MARKETABLE ASSET (DE)MOBILISATION EXECUTION - #59”

Or

“ECMS ENTITY - U2A MARKETABLE ASSET (DE)MOBILISATION READ ONLY - #60”

To retrieve an overview of all instructions, follow the instructions below.



After clicking on the “search” icon  , find a list of Counterparty Marketable Asset Instructions with Business Status “Rejected” and double click on the record.

In ECMS, a marketable asset instruction can either be rejected due to:

- A) A business validation error  (to be recognised by ‘[1]’ or a higher number) behind the button “Business Validation Errors”
- B) Rejection by T2S

Business Validation Errors

In case of a business validation error, please click on the "Business Validation Errors" button and a list will appear at the bottom of the screen (scroll down).

EXAMPLE:

BR Name	Blocking
MAIN015	The ISIN informed in a (de)mobilisation instruction must exist in the ECMS reference data

In this example, we get BR name (business rule name) "MAIN015" and the blocking description. To find more information about this error, check the ECB document "[Business Rules in the ECMS](#)". In this example, you get to see more detailed information about the error and in which field in the SWIFT sese.023 message the error was detected.

ECMS Rejection Codes

Code	Short description		Long description	Action to be taken
DDAT	Settlement Date Rejection	MAIN011	The Intended Settlement Date is before the date calculated via the predefined system parameter set by the ECMS operator.	The client must send a new instruction with a valid settlement date
DEPT	Place of Settlement Rejection. Unrecognised or invalid Place of Settlement.			The client must send a new instruction with a valid place of settlement. Adjust Counterpart Details party CSD.
DQUA	Unrecognised or invalid settlement quantity	MAIN032	When performing a demobilisation, the asset position must be equal or greater than the quantity informed in the demobilisation instruction.	Counterparties can only send instructions regarding positions they possess, it cannot be higher.
DTRD	Trade Date Rejection. Unrecognised or invalid trade date.	MAIN009	The Trade Date of a (de)mobilisation Instruction must be equal to or earlier than its intended settlement date	The client used a trade date that is later than the settlement date, this is not possible. The client must adjust the trade date.
REFE	Reference Rejection. The instruction has a reference identical to another previously received instruction	MAIN001	A (de)mobilisation Instruction already exists in ECMS for the same Account owner and with the same instruction reference. MAIN027-The T2S receiving securities account owner specified in the mobilisation instruction is not the same as the Account owner of the T2S receiving securities account derived from the ECMS reference data	The client has not instructed with his own account.
LATE	Market Deadline missed. Instruction is received after market deadline	MAIN037	The (de) mobilisation instruction has been received after the ECMS cut-off time.	The client has sent the instruction too late. The client must try again the next day.

Rejections by T2S

In case the button "Business Validation Errors" shows '[0]' instead of '[1]', [Business Validation Errors \[0\]](#), the reason for rejection is caused by T2S.

In that case, follow the following steps:

1. Click on [MA Settlement Instruction](#)
2. A list with Marketable Settlement Instructions will appear at the bottom of the screen. Scroll down and double

3. Click on [T2S Instruction Status \[1\]](#). (the '[1]' indicates that one rejection reason is applicable) and scroll down.
4. At the bottom of the page, double click on the record containing "REJT IPRC"

5. Click on [Reason Details \[2\]](#)

6. In this example, two reasons for rejections are found. In is longer than space available in the cell. In that case, on the reason field to retrieve the full text.
